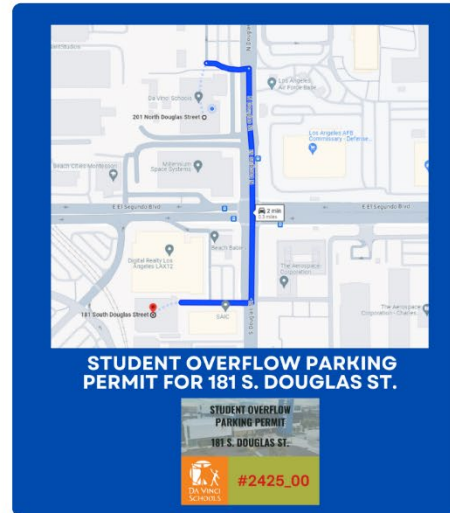
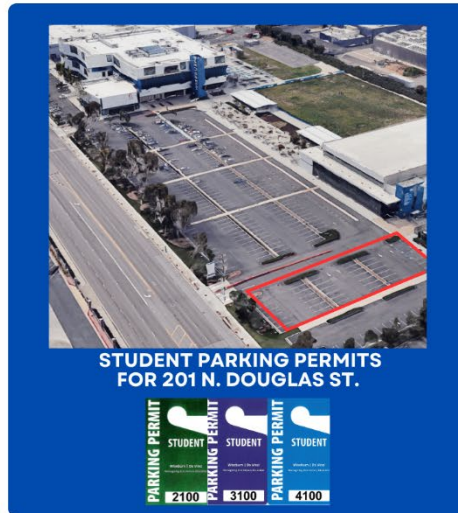




Designated Student Parking Areas 2024-25

Dear Parents and Students,

We hope you are all doing well as we continue into this new school year. Below is some very important information regarding parking at the 201 campus. To begin with, we would like to remind you that it is **mandatory** for all vehicles parked on the 201 campus to display a valid parking permit during school hours. This includes **all** students who drive to school and park on campus.

Displaying the parking permit helps us to identify authorized vehicles and ensures that our parking facilities are being used safely and efficiently. Failure to display a valid permit or park in your designated area can result in a parking citation or having your vehicle towed.

Since the start of the 24-25 school year, our Safety Officers, Grounds Supervisors, and other staff have been giving oral warnings to drivers who have parked without a permit. This week we began to issue written citations as well. (*NOTE: Any students who had a Temporary Permit issued to them that received a citation can bring it to their school's Front Office so it can be expunged.*)

After assessing the amount of parking needed for Da Vinci Schools and Wiseburn USD staff who work in the 201 N. Douglas building, we had to readjust the number of spaces that could be made available for student parking this year. We have also been keeping track of the number of open spaces in all the parking areas along with the number of vehicles parked without a permit

or in the wrong area. As such, each of the three schools, Communication, Design, and Science, were allocated 21 student parking spaces each in the North Lot to start off.

Knowing that we have a greater demand for student parking than what we can offer at the campus, we have again been working to arrange for overflow parking for students once the maximum number of student parking permits for on-campus parking spaces have been issued. We are glad to inform you that we have again successfully secured overflow parking at the parking structure located across the street at **181 S. Douglas Street** to begin next month, starting Tuesday, September 3, 2024.

Overflow Parking Instructions:

- Our designated overflow parking area is in the parking structure at 181 S. Douglas Street on the **second floor**, specifically in the **middle two rows between the signs that will be placed in the designated area**. Please make sure to park in these designated spots. Parking anywhere else in that structure without the proper permit could result in having the vehicle towed.
- Always display your Da Vinci Student Overflow Parking Permit visibly in your vehicle when parked in the structure.
- Attached to this email you will find a map highlighting the specific parking spaces set aside for our students. This will assist you in locating the correct area within the parking structure.
- As representatives of the Da Vinci Schools Community, please ensure to behave appropriately and treat the parking facility with the utmost respect.
- Any students who are assigned to park in the structure and are engaged in any school activities that run later into the evening may move their car back to any parking spaces available at the 201 campus.

In the event that both our on-campus student parking spaces and our overflow spaces reach capacity, there are areas near the 201 campus that have public street parking available. These include Coral Circle off of Douglas south of the campus, Grand Avenue west of the campus, and on or near Mariposa Avenue north of the campus (**not** in the parking lots of the local retail centers). Please take note of any parking restriction signs such as street sweeping or restricted hours of parking.

Thank you for your cooperation in helping us to maintain a safe and organized parking environment on campus.
